Sub: Introduction of On-line filing and tracking of loan applications

Sir,

In order to provide efficient and convenient services to their customers, the Public Sector banks have undertaken various e-governance initiatives which inter alia include on line filing of applications, including for loans for various purposes. Besides being convenient, such a system also brings in greater transparency in processing such proposals and allows tracking the disposal of such applications.

2. As the facility of on-line filing and tracking of applications was not available in many banks, a group comprising of officials of the Punjab national bank, Allahabad bank and Syndicate bank was set up to develop these applications. Some applications were developed and tested by these banks separately which were thereafter adopted by the other banks. As a result, each of these banks is in a position to offer all these services through on-line filing.

3. As a considerable work on the development and implementation of these applications has already been done, it is necessary that all other Public Sector banks take advantage of the work and introduce on-line filing and tracking of applications for such applications.

4. All Public Sector Banks are advised to implement the on-line filing and tracking of loan applications, as has been done by the aforementioned banks. A document containing the details of these applications is attached.

5. PSBS are also advised to contact the banks as under for any assistance/guidance in the introduction of on-line filing and tracking of loan applications.
