NOTIFICATION

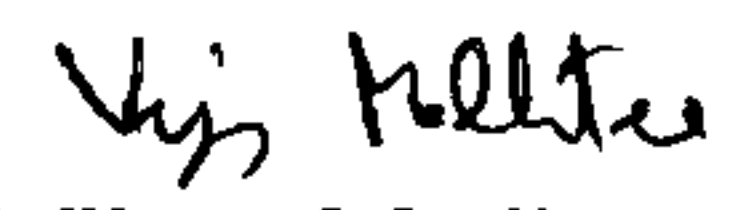
