VACANCY CIRCULAR

Sub: Filling up the posts in the Debts Recovery Tribunal-I, Chandigarh on deputation basis.

Application are invited for the suitable candidates, not exceeding 56 years of age with requisite qualifications and experience for the following posts to be filled up on deputation basis on the prescribed proforma attached as Annexure-II:-

1. **Section Officer (One post) Pay in the pay band of Rs.9300-34800/- + GP 4600/-(Pre-revised).**

Eligibility: (1) Officers in Central Government or State Government or in Courts holding analogous posts on regular basis and having a degree from recognized University OR.

(2) With eight years regular service in the Pay Band 2 of Rs.9300-34800+ Grade pay of 4200/- (Pre-revised) or equivalent and having a degree from a recognized University.

Desirable : Preference will be given to persons having experience in legal or judicial work.

2. **Assistant : (One post) Pay in the pay Band of Rs.9300-34800/- + GP 4200/-(Pre-revised).**

Eligibility (1) Officers in Central Government/State Government or in Courts holding analogous posts and possessing degree from a recognized University; OR

(2) Upper Division Clerks with eight years regular service in the pay Band of Rs.5200-20200+ Grade Pay of Rs.2400 or equivalent.

3. **Recovery Inspector (Two Posts) Pay in the pay Band of Rs.9300-34800/- + GP 4200/-(Pre-revised).**

Eligibility:

- (i) Officers holding analogous posts in Central Government/State Governments or in Courts and having degree from a recognized University ;
- (ii) Court Masters with eight years' regular service in the scale of Rs.5200-20200 + GP 2400/- or equivalent.

4. **Accounts Assistant (One Post) Pay in the pay Band of Rs.9300-34800/- + GP 4200/- (Pre-revised).**

Eligibility:

- (i) Officers of the Central Government holding analogues posts on regular basis; OR
- (ii) With three years; regular service in the pay scale of Rs.5000-8000 (Pre-revised); OR
- iii) With eight years' regular service in the pay scale of Rs. 5200-20200 + GP 2400/- (Pre-revised) or equivalent and having experience of working as Senior Accountant or Accountant, in the scale of Rs. 5200-20200 + GP 2400/-, (Pre-revised) who have undergone training in Cash and Accounts.

(ii) Stenographer Grade "D" with Eight years regular service in the pay scale of Rs.5200-20200 + GP 2400/- (pre-revised) or equivalent.

Pay Band + Grade Pay: Rs.5200-20200 + GP 2400/- (Pre-revised)

Qualification/Experience/Eligibility:

- i) Persons holding analogous posts in Central Government/State Government or in High Courts/Tribunals;
ii) Lower Division Clerks with 8 years regular service in the scale of Rs.5200-20200+GP Rs.1900/- (Pre-revised) or equivalent;
iii) Persons having knowledge of stenography will be preferred.

Pay Band + Grade Pay: Rs.5200-20200 + GP 2400/- (Pre-revised)

Qualification/Experience/Eligibility:

- (i) Analogous posts on regular basis OR

Qualification/Experience/Eligibility:

- (i) Employees of Central Government/State Government or in courts/Tribunal holding analogous posts on regular basis.



TERMS AND CONDITIONS FOR APPLICATION

1. Period of deputation including period of deputation in ex-cadre post held immediately preceding the appointment in the same or any other organization/department of Central Government should ordinarily not exceed three years.
2. All pay scales mentioned against the each post are pre-revised scales and the fixation of pay in respect of selected candidates, shall be in terms of notification of Government of India regarding Sixth Pay Commission (Pre-revised).
3. The Tribunals are quasi-judicial bodies set up under the provisions of Recovery of Debts Due to the Banks and Financial Institution Act 1993. The deputation will be governed by the terms and conditions as contained in the DOPT's O.M No. 6/8/2009-Estt. (Pay-II) dated 17.06.2010 as amended from time to time.
4. The number of vacancy may change at the time of filling of vacancies.
5. The candidates who apply for the post will not be allowed to withdraw their candidature subsequently.
6. All posts will be filled up on deputation basis for period of three years maximum.
8. Incomplete applications and those not received thorough proper channel are liable to be rejected.
9. Certified copies of ACRs/APAR of last five years alongwith vigilance clearance certificate by parent office must also be attached with application.
