VACANCY CIRCULAR

TEMRS AND CONDITIONS FOR APPLICATION

- 1. Period of deputation including period of deputation in ex-cadre post held immediately preceding the appointment in the same or any other organization/department of Central Government should ordinarily not exceed three years.
- 2. All pay scales mentioned against the each post are pre-revised scales and the fixation of pay in respect of selected candidates, shall be in terms of notification of Government of India regarding Sixth Pay Commission (Pre-revised).
- 3. The Tribunals are quasi-judicial bodies set up under the provisions of Recovery of Debts Due to the Banks and Financial Institution Act 1993. The deputation will be governed by the terms and conditions as contained in the DOPT's O.M No. 6/8/2009-Estt. (Pay-II) dated 17.06.2010 as amended from time to time.
- 4. The number of vacancy may change at the time of filling of vacancies.
- 5. The candidates who apply for the post will not be allowed to withdraw their candidature subsequently.
- 6. All posts will be filled up on deputation basis for period of three years maximum.
- 8. Incomplete applications and those not received thorough proper channel are liable to be rejected.
- 9. Certified copies of ACRs/APAR of last five years alongwith vigilance clearance certificate by parent office must also be attached with application.
