Subject: **Filling up of two posts of Member in Appellate Authority for Industrial and Financial Reconstruction (AAIFR).**

It is proposed to fill up two posts of Member in Appellate Authority for Industrial and Financial Reconstruction (AAIFR) urgently. The post is to be filled up on tenure basis. Applications are invited from the eligible officers who fulfilled the eligibility conditions as per provisions of SICA, 1985. Section 5 (3) of SICA, 1985 provides as under:

“A Member of the Appellate Authority shall be a person who is or has been a Judge of a High Court or who is or has been an officer not below the rank of a Secretary to the Government of India or who is or has been a Member of the Board (BIFR) for not less than three years”.

2. An applicant should not have attained the age of 65 years. He/She shall hold office for such period, not exceeding five years, as may be specified by the Central Government in the order of his appointment or till attaining the age of 65 years, whichever is the earliest. Person having at least two years, remaining for tenure will be preferred. However, the Government shall have a right to terminate the tenure of a member even before completion of the tenure due to unforeseen circumstances/developments.

3. The post of Member, AAIFR is in the pay scale of ` 80,000/- (fixed) plus other allowances as admissible under the AAIFR (Salaries and Allowance and Conditions of Service of Chairman and other Members) Rules, 1987 as amended from time to time.

4. The applications in respect of eligible officers, who are interested may be forwarded, duly verified/counter verified along with the following documents:

- (i) Application in the prescribed performa (Annexure).
- (ii) Vigilance clearance including certification that no disciplinary proceedings/criminal proceedings are either pending or contemplated against the applicant.

- (iii) A brief write up on the significant contributions made by the applicant during his/her present/pas assignment and his/her suitability for the post.
- (iv) Contact Details.

5.
