GSR (E):- In exercise of the powers conferred by section 55 of the National Housing Bank Act, 1987 (53 of 1987), the Board, with the previous approval of the Reserve Bank of India and in consultation with the Central Government, hereby makes the following regulations to further amend the National Housing Bank General Regulations, 1988, namely :-

1. (1) These regulations may be called the National Housing Bank General (Amendment) Regulations, 2004.
(2) They shall be deemed to have come into force on 9th May, 2000.
2. In the National Housing Bank General Regulations, 1988. in regulation 7.-
 - (a) in sub-regulation (1), for the words and figures "Rs.200", the words and figures "Rs.1,000" shall be substituted;
 - (b) in sub-regulation (2), for the words and figures "Rs.100", the words and figures "Rs.500" shall be substituted.
