- G. S. R....(E).- In exercise of the powers conferred by sub-section (2) of section 36 of the Recovery of Debts Due to Banks and Financial Institutions Act, 1993 (51 of 1993), the Central Government hereby makes the following rules regulating the method of recruitment to the post of Lower Division Clerk in Debts Recovery Tribunal 2, Ernakulam, namely:-
- 1. **Short title and commencement.-** (1) These rules may be called Debts Recovery Tribunal-2, Ernakulam (Lower Division Clerk) Recruitment Rules, 2016.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of post, classification, level in the pay matrix. The number of said post, their classification, pay band and grade pay or pay scale attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3. **Method of recruitment, age limit, qualifications etc..-** The method of recruitment, age limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (13) of the said Schedule.
- 4. Initial Constitution. Persons holding the post of Lower Division Clerk in Debts Recovery Tribunal-2, Ernakulam, on regular basis shall be, on the commencement of these rules, deemed to have been appointed as such under these rules, if such persons opt for such post within thirty days of the commencement of these rules, subject to the approval of the Presiding Officer, Debts Recovery Tribunal-2, Ernakulam. The regular service rendered by them in the post of Lower Division Clerk before the commencement of these rules shall be taken into account for deciding their eligibility for promotion etc. to the next higher grade.

5. Disqualifications.- No person -

- (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any other person;

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. **Power to relax**.- Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any provisions of these rules with respect to any class or category of persons.
- 6. Saving .- Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for Scheduled Castes, the Scheduled Tribes, Other Backward Classes, ex-servicemen, persons with disabilities and other special categories of persons, in accordance with the orders issued by the Central Government from time to time in this regard.
