It is proposed to fill up vacancies in the following posts in this Tribunal from suitable candidates from Central /State Government/Courts/Tribunals on deputation basis.

The educational qualification, experience and other eligibility conditions for the posts are furnished against each post as 'Annexure-I'. The candidates selected shall be appointed on deputation basis for a period of one year in the first instance, which may be extended upto three years.
