#### VACANCY CIRCULAR

The Debts Recovery Tribunal is a quasi-judicial body set up under the provisions of the Recovery of Debts Due to Banks and Financial Institutions Act, 1993 by the Ministry of Finance, Department of Financial Services, Government of India.

- 2. Applications are invited from suitable candidates from Central Government /State Government / Courts / Tribunals not exceeding 56 years of age (as on closing date for receipt of applications) with requisite qualifications and experience for appointment to the vacant posts of Accounts Assistant (one), Recovery Inspectors (two), Stenographers Grade 'C' (two), Stenographer Grade 'D' (one) Court Master (one) and Lower Division Clerks (two) in the Tribunal by transfer on deputation basis. Pay and eligibility conditions prescribed for each of the above posts are given in Annexure I.
- The period of deputation shall be initially for a period of one year but extendable up to three years or curtailed by the Competent Authority at its discretion as per rules.
