The post of Chief Vigilance Officer in Union Bank of India is falling vacant on 16-11-2013. You are requested to ascertain the officers of the rank of General Manager or Deputy General Manager, having three years experience in the grade of DGM, desirous of being considered for appointment as CVO, Union Bank of India and forward the names of such officers along with their complete Bio-data in the format enclosed (under signatures of CVO of the bank) and their attested Annual Confidential Reports for the last five years (complete) in all respects including vigilance clearance to this Department on or before 24<sup>th</sup> May, 2013. It may be ensured that names of only those candidates whose services can be spared and who have minimum of 3 years of service remaining as on 16.11.2013 and are clear from vigilance angle are forwarded. The following case will not be considered:

- (i) The officers against whom some or the other penalty had been imposed in the past 10 years.
  - (ii) The officers having less than three years of service as on 16-11-2013.
2. The names of candidates once forwarded will not be permitted to be withdrawn in any circumstances. Therefore, while forwarding the names of candidate for CVO in the above Bank, an undertaking may be obtained from the applicants to the effect that under no circumstances, they would withdraw their candidature once a decision is taken to nominate them as CVO in the Bank and a copy thereof may also be furnished to this Department.
