- (iii) COURT MASTER (Rs.5200-20200/- + GRADE PAY Rs.2400/- pre-revised Rs. 4000-100-6000/-) (01 Post): Employees of Central Government/State Governments or in High Courts/Tribunals holding analogous post on regular basis or posts of Lower Division Clerk with 8 years regular service in the scale of Rs.5200-20200/- + Grade Pay Rs.1900/- (Pre-revised Rs.3050-75-3950-80-4590/-) or equivalent. Persons having knowledge of stenography will be preferred.
- (iv) <u>STENOGRAPHER GRADE 'D'</u> (Rs.5200-20200/- + GRADE PAY Rs.2400/-pre-revised Rs. 4000-100-6000/-) (01 Post): Employees of Central Government or State Government or Courts/Tribunals holding analogous post on regular basis or 5 years regular service as LDC in the Scale of Rs.5200-20200/- + Grade Pay Rs.1900/- (Pre-revised Rs. 3050-75-3950-80-4590/-) or equivalent and possessing the qualification of Matriculation or equivalent with a speed of 80 words per minute in shorthand (English) and 30 words per minute in typing (English).

(v) LOWER DIVISION CLERK (Rs. 5200-20200/- + GRADE PAY Rs.1900/- pre-revised Rs. 3050-75-3950-80-4590/-) (03 Posts): - Employees of Central Government/State Governments or Courts/Tribunals holding analogous post on regular basis and possessing the qualification of Matriculation or equivalent with a minimum speed of 30 words per minute in English or 25 words per minute in Hindi typewriting. Desirable - Acquaintance with word processing.

Note:-

- i) Period of deputation including period of deputation in ex-cadre post held immediately preceding the appointment in the same or any other Organisation/Department of Central Government should ordinarily not exceed three years. (The maximum age limit for deputation shall be 56 years on the last date of receipt of applications).
- ii) The Tribunal is a quasi-judicial body set up under the provisions of the Recovery of Debts due to Banks & Financial Institutions Act, 1993. The deputation will be governed by the terms & conditions as contained in the DOPT's O.M. No.6/8/2009-Estt (Pay II) dated 17/06/2010 as amended from time to time.
