OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

3. **Payment**

9. The Service Provider's Registered Head Office must be located at the consignee's (user's) location to ensure effective coordination, smooth service delivery, and streamlined administrative processes. Bidders are required to provide complete office address details, landline number, Contact Person's name, and mobile number with their bid. Failure to submit these details will result in rejection of the offer.
10. L1 Determination from "Multiple L1" bidders in Services:
 - a) In case of multiple L1 bidders against a service bid, the buyer will use 'Run L1 selection' feature wherein the system would randomly identify a L1 seller. It works on pseudorandom number generator algorithms which is the system generated or based on linear congruential algorithm.
 - b) The system selected L1 bidder is required to confirm within 72 hours whether bidder is willing to execute the contract. If the bidder says "No" or does not reply, system will enable Re-Run L1. This process will continue till the system selected L1 bidder confirms the willingness for execution of contract. Suitable action is taken against the defaulter bidders as per the Incident Management Policy of GeM.
