Applications are invited for the posts of 06 (six) Additional Chief Vigilance Officers (Addl. CVOs) on deputation basis in various Public Sector Banks (including State Bank of India). The details of posts are as under:

2. The details are given in following paragraphs.

3. Tenure:

The deputation tenure of Addl. CVOs will be for 03 years or till age of superannuation or till further orders, whichever is earlier.

4. Pay Scale/Perquisites admissible to Addl. CVOs:

The officers selected as Additional CVOs in PSBs shall draw their existing pay of their parent organisation plus <u>deputation allowance thereon equal to 10% of their basic pay</u>. They will be entitled to perquisites admissible to next higher position in the borrowing organisation. However, they may also choose to retain the perquisites they are eligible for in their parent organizations.

5. Eligibility:

- a) Officers of the level of Deputy General Manager (DGM) of Public Sector Banks including that of State Bank of India (with 2 years' experience, preferably in vigilance/credit matters at DGM level) with a minimum of 03 years' residual service, shall be eligible to apply for the above post.
- b) The candidate should possess requisite experience in handling large value advances and should also have sufficient exposure in other verticals.
- c) The candidate is not eligible for being appointed to the post of Additional CVO in his/ her parent bank.

6. Selection Process:

Selection of the candidates for appointment to the post shall be made by the Government, on the basis of their service records and interaction with the Selection Committee.

7. Exercise of choice:

At present, all the posts being notified in this advertisement for filling up are located at Mumbai. However, the location as specified in this advertisement are subject to change and the Candidates selected are liable to posted at any location in India as determined by this Department. Candidate will be placed to the extent possible, on the basis of merit cum preference of the candidate in any Public Sector Bank being notified in this advertisement. However, Government reserves the right to take the final decision in the matter.

Forwarding of applications:

Respective organisations are requested to forward the applications/ names of the willing officers along with their complete bio-data in the format enclosed, and attested copies of their Annual Performance Assessment Reports (APARs) for the last five years (complete in all respects) i.e. from 2020-21 to 2024-25, to this Department on or before 17.10.2025 by 5:00 PM. While forwarding the names of the willing officers, it may be ensured that:

- a) the services of the willing candidates can be spared for at least 03 years for taking up this assignment; and
- b) the applicant must have a minimum of 03 years of service remaining as on the last date of submission of applications i.e. **17.10.2025**.
- c) the officer should not have any vigilance cases pending against them;
- d) the names of the officers who are under period of debarment need not be sent;
- e) officers, against whom any major or minor penalty has been imposed in their career as a result of any disciplinary proceeding, are not eligible to apply for the post of Addl. CVOs and thus, their applications may not be forwarded.
- 9. The names of candidates once forwarded for these posts will not be permitted to be withdrawn in any circumstances. Therefore, while forwarding the names for consideration, an undertaking may be obtained from the applicants to the effect that under no circumstances, they would withdraw their candidature once a decision is taken to nominate them for the post of Addl. CVO. While forwarding the application for these posts, a copy of this undertaking should be enclosed along with other requisite documents.

- 10. In the event of selection of the officer to one of these posts, the concerned officer shall be given 15 days' time to join new post/assignment of Addl. CVO, from the date of receipt of the order. If no response is received after 15 days, or if the officer fails to report for the assignment at designated place by given date, the process of his/her debarment for deputation in any organisation for a period of 05 years shall be initiated by his/her parent organisation after issuing a notice to that effect to the officer concerned. The formats for application have been prescribed in Annexure [Form 1, 2, 3].
- 11. The willing officers may send advance copy of their application in this regard to this Department for information by email at *vigilance-dfs@nic.in*. However, their candidature shall be considered only after receipt of the hard copies of the application through official channel.
