#### VACANCY CIRCULAR

Applications are invited from eligible candidates of Central / State Governments for selection to the vacancies in various categories existing in this Tribunal (as per Annexure-I), on deputation basis. The candidates applying for the deputation post must be below 56 years of age as on the closing date for receipt of application. Applications in the prescribed format (as per Annexure II) of willing and eligible candidates who can be relieved shortly, along with attested copies of last five years ACRs/APARs and the original certificate from the Controlling authority (as per Annexure III) may be forwarded to the undersigned within 45 days from the date of this circular. Candidates shall not be allowed to withdraw their candidature after the selection process is over. Advance copy will not be accepted. Applications with incomplete information or are received after the last date or not received through proper channel, will not be considered. Candidates from Autonomous Bodies need not apply.
