Applications are invited for the post of Chairman & Managing Director, SIDBI having its headquarters at Lucknow from suitably qualified and experienced candidates, not more than 55 years of age, as on 09.11.2013.

Small Industries Development Bank of India (SIDBI) was established on 2nd April 1990. The Charter establishing it, The Small Industries Development Bank of India Act, 1989 envisaged SIDBI to be "the principal financial institution for the promotion, financing and development of industry in the small scale sector and to coordinate the functions of the institutions engaged in the promotion and financing or developing industry in the small scale sector and for maters connected therewith or incidental thereto". SIDBI is headed by a full time Chairman & Managing Director appointed by Central Government and has its head office at Lucknow.
