I am directed to say that the Recovery of Debts Due to Banks and Financial Institutions Act, 1993 (51 of 93), was enacted to provide for establishment of Tribunals for expeditious adjudication and recovery of debts due to banks and financial institutions. Under Section 8 of the Act, 5 Debts Recovery Appellate Tribunals (DRAT's) have been established at Delhi, Mumbai, Kolkata, Chennai and Allahabad.

- 2. The prescribed qualifications for appointment to the post of Chairperson of DRAT are as under:
 - a) A person who is, or has been, or is qualified to be, a Judge of a High Court; or
 - b) A person who has been a member of the Indian Legal Service and has held a post in Grade-I of that Service for at least three years; or
 - c) A person who has held office as the Presiding Officer of a Debts Recovery Tribunal for at least three years.
- 3. The term of office of Chairperson of DRAT is five years or till the age of 65 years, whichever is earlier.
- 4. The service conditions of the persons selected for the post of Chairperson are regulated in accordance with DRAT (Salaries, allowances and other terms and conditions of service of Chairperson) Rules, 1993 (copy enclosed).
- 5. The post of Chairperson in DRATs at Allahabad, Delhi and Mumbai are anticipated to fall vacant on 31.12.2013, 1.2.2014 and 14.1.2014 respectively. Willing and eligible High Court Judges (serving or retired) and other candidates who are eligible for appointment as High Court Judges, may apply on the attached *pro forma*. The applications in response to this circular should reach this Ministry latest by 16th August, 2013.
- 6. The candidates who are working should apply through proper channel alongwith vigilance clearance and attested photocopies of the Annual Confidential Reports for the last five years i.e. 2008-09 to 2012-13. Direct/Advance/incomplete applications or applications not accompanied by desired information will be summarily ignored.
