Undersigned is directed to refer case no. 85/1041/12-13 dated 20-05-2014 received from the court of Chief Commissioner for Persons with Disabilities (copy enclosed) on the subject mentioned above and to say that it has been brought to the notice of Chief Commissioner for Persons with Disabilities that most of the CPSEs are not implementing the instructions issued by DPE O.M. No. 6(9)2005-DPE(SC/ST Cell) dated 9th December 2010 to all administrative Ministries / Departments concerned with Central Public Sector Enterprises (CPSEs).

2. As per the Section 33 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 atleast 3% of the vacancies should be reserved in the identified posts for Persons with Disabilities.

3. It is, therefore, requested that appropriate instructions may be issued to all the CPSEs under the administrative control of your Ministry/Department to follow the above provision of Persons with Disabilities Act, 1995 and instructions of DPE dated 09-12-2010.


