VACANCY CIRCULAR

Sub: Filling up the posts in the Debts Recovery Tribunal-I, Chandigarh on deputation basis.

Application are invited for the suitable candidates, not exceeding 56 years of age with requisite qualifications and experience for the following posts to be filled up on deputation basis on the prescribed proforma attached as Annexure-II:-

1. Section Officer (One post) Pay in the pay band of Rs.9300-34800/- + GP 4600/-

Eligibility (1) Officers in Central Government or State Government or in Courts holding analogous posts on regular basis and having a degree from recognized University.

(2) With eight years regular service in the Pay Band 2 of Rs.9300-34800+ Grade pay of 4200/- or equivalent and having a degree from a recognized University.

Desirable : Preference will be given to persons having experience in legal or judicial work.

2. Assistant : (One post) Pay in the pay Band of Rs.9300-34800/- + GP 4200/-

Eligibility (1) Officers in Central Government or State Government or in Courts holding analogous posts and possessing degree from a recognized University; or

(2) Upper Division Clerks with eight years' service in the pay Band of Rs.5200-20200+ Grade Pay of Rs.2400 or equivalent.



3. Recovery Inspector (Two Posts) Pay in the pay Band of Rs.9300-34800/- + GP 4200/-

Eligibility:

- (i) Officers holding analogues posts in Central Government/State Governments or in Courts and having degree from a recognized University ;


- (i) Employees of Central Government/State Government or in Courts/Tribunal holding analogous posts on regular basis ; Or

- (i) Employees of Central Government/State Government or in courts/ Tribunal holding analogous posts on regular basis.
