VACANCY CIRCULAR

Sub: Filling up the posts in the Debts Recovery Tribunal-III,  
Chandigarh on deputation basis.

Applications are invited for the suitable candidates, not exceeding 55 years of age with requisite qualifications and experience for the following posts to be filled up on deputation basis on the prescribed proforma attached as Annexure-II:-

1. Section Officer (One post): Pay in the Pay Band of Rs.9300-34800/- + GP Rs. 4600/-

Eligibility: (1) Officers in Central Government or State Government or in Courts holding analogous posts on regular basis and having a degree from recognized University or;

(2) With eight years regular service in the Pay Band 2 of Rs.9300-34800+ Grade pay of 4200/- or equivalent and having a degree from a recognized University.

Desirable: Preference will be given to persons having experience in legal or judicial work.

2. Private Secretary (One Post): Pay in the Pay Band of Rs.9300-34800/- + GP Rs. 4600/-

Eligibility: (1) Officers in Central Government or State Government or in Courts holding analogous posts on regular basis and having a degree from recognized University or;

(2) Stenographers Grade "C" with eight years regular service in pay Band II of Rs.9300-34800+ Grade pay of 4200/- or equivalent and having a degree from a recognized University.

Desirable : Preference will be given to persons having experience in legal or judicial work.

3. Recovery Inspector (One Posts): Pay in the Pay Band of Rs.9300-34800/- + GP Rs. 4200/-

Eligibility: (1) Officers holding analogous posts in Central Government/State Governments or in Courts and having degree from a recognized University or;

(2) Court Masters with eight years' regular service in the scale of Rs.5200-20200 + GP 2400/- or equivalent.

4. Assistant : (One post) Pay in the pay Band of Rs.9300-34800/- + GP 4200/- (Pre-revised).

Eligibility (1) Officers in Central Government/State Government or in Courts holding analogous posts and possessing degree from a recognized University; OR

(2) Upper Division Clerks with eight years regular service in the pay Band of Rs.5200-20200+ Grade Pay of Rs.2400 or equivalent.

5. Accounts Assistant (One Post): Pay in the Pay Band of Rs.9300-34800/- + GP Rs. 4200/-

Eligibility: (1) Officers of the Central Government holding analogous posts on regular basis; or;

- (2) With three years regular service in the pay scale of Rs. 5000-8000 or;
- (3) With eight years' regular service in the pay scale of Rs.4000-6000 or equivalent and having experience of working as Senior Accountant or Accountant in the scale of Rs.4000-6000, who have undergone training in Cash and accounts.

6. Steno Grade "C" (Two Posts): Pay in the Pay Band of Rs. 9300-34800/- + GP Rs. 4200/-

Eligibility: (1) Officers of the Central Government/State Government or in Courts holding analogous posts on regular basis; or

(2) Stenographer Grade "D" with Eight years regular service in the pay scale of Rs.5200-20200 + GP 2400 or equivalent.

7. Steno Grade "D" (One Post): Pay in the Pay Band of Rs. 5200-20200/- + GP Rs. 2400/-

Eligibility: (1) Analogous posts on regular basis or

(2) With 5 years regular service as LDC in the scale of Rs.5200-20200 + GP 1900/- or equivalent and possessing the qualifications prescribed for direct recruits i.e. Matriculation or equivalent with a speed 80 words per minute in shorthand (English) 30 words per minute in typing (English).

8. U.D.C./ Cashier (Two Posts): Pay in the Pay Band of Rs. 5200-20200/- + GP Rs. 2400/-

Eligibility: (1) Employees of Central Government/State Government or in Courts/Tribunals holding analogous posts on regular basis; or

(2) Holding post of LDC with Eight years regular service in the pay scale of Rs.5200-20200 + GP 1900/- or equivalent.

9. Court Master (One Post): Pay in the Pay Band of Rs. 5200-20200/- + GP Rs. 2400/-

Eligibility: (1) Persons holding analogous posts in Central Government/State government or in High Court/Tribunals or

(2) Lower Division Clerk with eight years regular service in the scale of Rs. 5200-20200 + GP 1900/- or equivalent.

(3) Persons having knowledge of Stenography will be preferred.

9. LDC/Typist (Four posts): Pay in the pay Band of Rs. 5200-20200/- + GP Rs. 1900/-

Eligibility: (1) Persons holding analogous posts in Central Government/State Government or in High Courts/Tribunals.

(2) Matriculation or equivalent with a minimum speed of 30 wpm in English or 25 wpm in Hindi Typewriting.

Applications of willing and eligible candidates in the prescribed proforma along with certificate of Parent Office may be forwarded to this office through proper channel only along with attested copies of last five years ACRs. The last date of receipt of applications in this office will be up to 31.12.2016.
