The selected candidate will be appointed on deputation basis initially for a period of <u>four years</u>, which may be extended as per norms subject to satisfactory performance and other terms and conditions. - 4. The departmental officials in the feeder grade who are in direct line of promotion, shall not be eligible for consideration for appointment on deputation. Similarly, a deputationist in the DRAT/DRTs under the jurisdiction of DRAT, Chennai shall not be eligible for consideration for absorption or promotion.
